### **Comments:**

**6.3.09** - "Cooler weather has slowed the drying process in the Central San Joaquin Valley as most wheat is still a week to two weeks away from being able to start harvest. We are seeing an average of around 13% on all wheat received thus far with a fair amount of variability. Yields are looking good so far with the highest yielding fields still maturing. Forecasts are calling for thunderstorms throughout the growing region for the end of the week and weekend. Rainfall should be sporadic, and hopefully not enough to cause any major sprouting damage or incidents of black tip on durum wheat." Geoff Schulz Penny-Newman Grain Company, Fresno CA

## **Karnal Bunt Survey Concludes**

The USDA/CDFA Karnal Bunt survey has concluded for the year in the Blythe area with no positive detections. The sampling included 30 fields and 1280 acres of wheat. This makes five years of sampling without a positive find and should allow some fields to be deregulated. There are tillage requirements that need to be met however to allow deregulation on the total area.
